The Website is not directed to children under the age of 18. If You are a minor under the age of 18 You must not use the Website or provide us with your personal data, except with the express consent and authorization of your parents or legal representatives.

#### 1. WHAT DATA WE COLLECT

ensure the security of the personal data You provide to DAC Beachcroft Argentina S.A, the same criteria and due of diligence as DAC Beachcroft Argentina S.A. applies to safeguarding its own information will apply.
